Bill of quantities – Item 15, ICT network and interior installations, 3. Copper phone cables:	The layout of the DC 8 cabinet (RO-8 cable distribution cabinet) and the layout of the passive equipment in it are given in Figure T1-13 in the Construction Permit Design.
What type and model of cabinet it is, as well as the capacity or number of 10x2 terminal blocks?	A cable telephone cabinet is planned for indoor mounting on wall with a capacity of min. 20 strips 10x2 cat 5, and 5 guides for shunting wire and possible accommodation of Overvoltage protection.
	Tentative dimensions of DC 8 cabinets are: 550x330x145 mm.

 Bill of quantities – Item 15, ICT network and interior installations, 2.a TC infrastructure relocation: It is required to clarify on which existing telecommunication installations is referred to, since 	Relocation and protection of the existing infrastructure (copper cables, optical cables and TC ducts) refers to the construction of new TC infrastructure, but without compromising the existing functionality, and as given in the Terms of Telekom Srbija no. 171373 / 2- 2018, dated 22.05.2018. and in Location Conditions.
