Furthermore, it is our understanding that Contractor is legally obliged that such excavated riverbed material shall be exclusively used to carry out backfilling and not use for any other commercial purposes. We also understand that PZI would require approval from the Engineer engaged on this project.

Having reviewed the tender documents, we have the following question:

We seek your confirmation/clarification that an international Contractor qualified under this tender would be granted free access by the Contracting Authority (MCTI) to excavate borrow pits in the river Danube (identified through PZI documentation) by its own dredging equipment as a chosen mode of BoQ specified "procurement" of riverbed material.
