Would you please give us an example or provide further explanation about this form?	Kindly note that the purpose of this form is authorization of your potential payments, in case of a contract award. No payments can be executed in your favor as long as your bank's information is not provided. The financial information required is the financial information that shall accompany your invoice in case of the contract award. If awarded the contract if any changes appear in your financing information, you will be requested to re-submit this form with new financial information. If it's Registered Capital, we can't figure out the difference among these 4 description 'Amount, Currency, Authorized, and Issued'.	The required information "basic capital" relates to "registered capital" meaning capital invested by founders upon registering a legal entity.
