Therefore, please consider whether it is possible for a candidate to issue a Statement of Integrity confirming that such key</p>	<p>Answer No 1</p> <p>The proposal is not in line with the requirements of the Tender Dossier. The Tender must contain information in full compliance with Volume 1, Section 1 Instructions to Tenderers, Clause 12 – Information/Documents to be supplied by the Tenderer.</p>

Kindly refer to Key and non-key staff requirements under Technical and Professional capacity of the Candidate, Volume 1 Section 1 Instructions to Tenders.</p> <p>Experts proposed as key-staff are subject of evaluation and they shall not be proposed as non-key staff.</p>
<p>Question No 3</p> <p>Please confirm that materials of embankment can be borrowed from the area adjacent to the construction line in the Danube river and please provide the particle size of the sand that can be taken from the place mentioned above.</p>	<p>Answer No 3</p> <p>Please, refer to Clarifications No. 3, 7 and 38.</p> <p>Borrowing area shall be defined within the Construction design, which is Contractor's responsibility.</p>
