1. The Republic of Serbia (RoS) has received financing from the World Bank toward the cost of the Western Balkans Trade and Transport Facilitation Project (WBTF), and intends to apply part of the proceeds toward payments under the Contract for Procurement of Design, Civil Works, Supply and Installation of Equipment to Increase Safety at Railway Level Crossings. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing, except for those payments, which the Contract provides to be made through letter of credit.

2. The Ministry of Construction, Transport and Infrastructure (MCTI) now invites sealed Bids from eligible Bidders for:

Lot 1 - Design, civil works, provision, installation and commissioning of RLC, I group

Lot 2 - Design, civil works, provision, installation and commissioning of RLC, II group

The aim of this bid is to carry out services and works for railway level crossings (in total 58) identified as weak points in rail infrastructure that significantly jeopardize traffic safety and efficiency in Serbia

Scope of work includes design preparation, civil works, signaling and telecommunication works, electrical and power supply works and traffic works (railway technology and signalization for tail and road) and will be implemented at following railway tracks:

Lot 1 (36 railway level crossings):

- Ruma-Sabac-branch-line junction Donja Borina – state border – (Zvornik Novi),
- Belgrade Centre – Pancevo main - Vrsac – state border – (Stamora Moravita),
- Subotica - Bogojevo – state border – (Erdut)
- Vrbas-Sombor,
- Lapovo – Kraljevo – Lesak – Kosovo Polje – Djeneral Jankovic – state border – (Volkovo),
- Stalac - Kraljevo – Pozega,
- Crveni krst - Zajecar - Prahovo port,
- Belgrade – Mladenovac – Lapovo – Nis – Presevo – state border – (Tabanovce),
- Pancevo Main – Zrenjanin – Kikinda – State border (Jimbolia),
- Belgrade – Resnik – Pozega – Vrbnica – State border.

Lot 2 (22 railway level crossings):

- Belgrade – Resnik – Pozega – Vrbnica – State border,
- Belgrade – Mladenovac – Lapovo – Nis – Presevo – State border - (Tabanovce).

It is anticipated that the Contract will start in February 2023 with maximum duration of 18 months and Defect Liability Period of 24 months.

3. Bidders may Bid for one or several contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Bid.

Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers” (July 2016, revised November 2017) (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations.

4. Interested eligible Bidders may obtain further information from the Central Fiduciary Unit of the Ministry of Finance and inspect the bidding documents from 09:00 to 15:00 hours at the address given below.

The bidding document in English only may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **EUR 50.00** or equivalent in Serbian Dinars (RSD) based on the selling exchange rate published by the National Bank of Serbia on the date of payment.
